#### 1. Building Meaningful Partnerships Between IPS and the Justice System

<u>Description:</u> Join this session to discuss strategies for building partnerships (state-level and program-level) with departments in the justice system. How can relationships between IPS and the justice system support job seekers? What have different states/programs done to reach out to justice departments?

#### 2. Trauma Informed Care in IPS

<u>Description</u>: Ready to rethink how we support job seekers with lived experience of trauma? Join this dynamic interactive breakout session to discover how trauma-informed care can transform the way we approach supported employment through IPS. We'll unpack and explore strategies on how to meet people where they are, how trauma impacts employment, building trust, fostering resilience, equity and supporting healing. We'll also delve into how trauma affects the nervous system and mental health and how this shows up in employment. Learn how we, as providers, can create safe, empowering pathways to work by understanding the brain-body connection, regulating our own responses, and supporting individuals navigating mental health challenges with empathy and intention.

## 3. IPS for Individuals Who Receive Temporary Assistance for Needy Families (TANF)

<u>Description</u>: In 2020, 41 million people received SNAP benefits. Of that group, 94% were living in poverty and 31% were unemployed. The majority of the session will focus on lessons learned in providing IPS services to Supplemental Nutrition Assistance Program (SNAP)-Temporary Aid to Needy Families (TANF) recipients. We will share successes achieved, challenges encountered, and strategies used to help increase employment outcomes.

### 4. IPS for Individuals with Substance Use Disorders

<u>Description</u>: This breakout group will be an interactive discussion exploring the tools, resources, and techniques to address barriers seen in programming helping individuals with substance use disorder obtain and maintain employment.

## 1. IPS for Individuals with Autism Spectrum Disorder

Join us to be a part of developing questions for a new employer survey and contribute to improvement of services for job seekers who are impacted by the justice system.

## 5. Helping IPS Participants Who Experience Homelessness

<u>Description</u>: Homelessness impacts millions worldwide, creating barriers to employment and stability. This workshop explores how the Individual Placement and Support (IPS) model is being adapted to address the unique needs of homeless populations through innovative research in England and Los Angeles. Attendees will learn about evidence-based strategies, share experiences, and discuss overcoming challenges such as stigma, trauma, and employer engagement to improve employment outcomes and pathways out of homelessness.
